





Introduction

In the spring of 2022 the Clinton County Health Department (CCHD) surveyed Clinton County residents to provide perspective about community health. Residents were asked to identify features of a strong, vibrant, healthy community; for their opinions on health, social and environmental challenges in the community; to identify health and social challenges and any barriers to medical care experienced by themselves or a family member within the past year; and, for demographic information about individual respondents and their households. The summary below outlines what respondents who indicated they reside in Champlain (including Rouses Point) identified as features, challenges or barriers and highlights how they compare to the responses of all Clinton County respondents.

Findings

A total of 1,081 responses were received from Clinton County residents. Sixty-nine (69) of the respondents indicated they reside in Champlain (including Rouses Point).

Demographics of Survey Respondents

The overall demographics of survey respondents who reside in Champlain (including Rouses Point) were aligned with those of Clinton County respondents overall. Three-quarters of survey respondents (76.81%) identified as female, 20.29% of respondents identified as male, and 1.45% identified as non-binary (1.45%) of respondents chose not to answer this question). In regards to age, the majority of respondents were ages 45-64 (31.88%), followed by ages 25-44 (26.09%), ages 65-79 (24.64%), 80 years and older (15.94%), and ages 18-24 (1.45%). There were no responses from individuals age 17 and younger. All respondents indicated that the primary language spoken in their household was English. Ninety-four percent of respondents reported their race/ethnicity as white, while one respondent selected Black or African American and one respondent selected American Indian (1.45% each). The highest level of education completed by survey respondents was diverse; 1.45% completed some high school but did not finish; 20.29% obtained a high school diploma or GED; 30.43% completed some college or obtained a technical or trade school certificate, or an Associate's degree; 37.68% obtained a Bachelor's degree; and 10.14% obtained a Master's degree or higher. The household annual income reported by respondents also varied; 20.28% reported a household annual income of less than \$24,999; 21.74% reported \$25,000-\$49,000; 28.99% reported \$50,000-\$99,999; and 14.50% reported \$100,000 or more. The majority of respondents are employed full-time (46.38%), retired (34.78%), or disabled (10.14%). When asked if they had a primary care provider (PCP), 89.86% of respondents indicated they were currently being followed by a PCP. The breakdown for all respondents' responses to demographic questions can be found in Table 1.

Definition of a Healthy Community

When asked whether they believed they live in a healthy community, 65.22% of respondents agreed or strongly agreed that they live in a healthy community, 15.94% disagreed or strongly disagreed, and 18.84% of respondents felt neutral toward this statement. Respondents were then asked to identify features of a

strong, vibrant, healthy community. The top features reported by residents were affordable housing (33.33%); health care services (33.33%); a safe environment (33.33%); a clean environment (30.43%); and livable wages (28.99%). The feature that Champlain (including Rouses Point) respondents ranked lowest were good childcare (2.90%); diverse populations (5.80%); equality (5.80%); and senior housing (5.80%). When compared to county responses, Champlain (including Rouses Point) residents were more likely to select senior services (14 percentage points) and less likely to select good schools (14 percentage points) as top features. See *Figure 1* for perceptions of living in a healthy community by residents and *Figure 2* for the top features of a strong, vibrant, healthy community.

Health Challenges of Concern and Experienced

Champlain (including Rouses Point) residents identified chronic disease (40.58%); substance abuse (39.18%); access to health care specialists (36.23%); access to health care services (33.33%); and mental health (31.88%) as the top health related challenges of concern in the community. More than 94% of respondents reported they or a family member experienced one or more health challenge in the past year. The top challenges reported were issues related to aging (43.08%); mental health (36.92%); chronic disease (32.30%); access to dental care (27.69%); access to a health care specialist (27.69%); and overweight/obesity (27.69%).

Almost 40% of respondents identified substance abuse as a health challenge in the community, while just over 12% of respondents reported it as a health challenge experienced by themselves or a family member within the past year. Conversely, 43.08% of respondents identified they or a family member experienced issues related to aging within the past year, though less than 30% identified it as a health challenge of concern in the community. Two in five respondents identified chronic disease as a health challenge in the community and over 30% of respondents reported they or a family member experienced chronic disease themselves in the past year. Furthermore, more than 36% of respondents identified access to health care services as a top health challenge in the community, while just over 21% reported they or a family member had trouble accessing health care services. However, over 60% of respondents reported they or a family member experienced at least one barrier to receiving medical care in the past year. The most reported barriers included: co-pays or deductibles were too high (42.86%), could not afford (35.71%), did not have dental or vision insurance (30.95%), no specialist appointment was available (30.95%), and there was no specialist locally (28.57%). Social Challenges of Concern and Experienced

Residents who reside in Champlain (including Rouses Point) identified the same top three social challenges in the community as all Clinton County residents surveyed, affordable housing (40.58%), lack of a livable wage (42.03%), and access to healthy foods (28.99%). Their next ranked social challenges in the community were lack of support for seniors (24.64%) and transportation (24.64%), both of which higher than county responses (17 and 16 percentage points respectively). More than three-fourths (75.36%) of respondents reported they or a family member experienced at least one social challenge in the past year. The most common challenges faced were lack of a livable wage (44.23%); lack of employment

opportunities (26.92%); transportation (25.00%); access to healthy foods (21.15%); and lack of support for seniors (21.15%). More than 40% of respondents identified affordable housing as a top social concern in the community, while only 15% or their family members experienced issues related to affordable housing within the past year. More than 2 in 5 (42.03%) respondents identified lack of a livable wage as a top social concern in the community and 44% of respondents or a family member experienced it in the past year. Environmental Concerns


More than half of residents identified aging infrastructure (57.97%) or drinking water quality (55.07%) as top environmental concerns in the community, while 43.48% identified stream, river or lake quality and 31.88% identified agricultural runoff. Champlain (including Rouses Point) residents were less likely to select climate change (21.74%) and school safety (23.19%) than county residents (32.78% and 33.33% respectively). Self- Perceived Physical and Mental Health

The majority of respondents self-reported their physical health as average (46.38%) or good (26.09%). Over 10% reported their physical health as excellent and 17.39% reported their physical health as poor or extremely poor (about 7 percentage points higher than county respondents). A similar pattern in responses was seen for self-reported mental health with 88.41% of respondents reporting their mental health as average, good or excellent; 11.59% of respondents reported their mental health as poor, and zero respondents reported their mental health as extremely poor. 




Figure 3: Clinton County Community Health Assessment Community Survey, Champlain/ Rouses Point Health Concerns (n=69)* 41% 40% 33% 32% 29% 30% 20% Champlain (including Rouses Point) Chronic disease ■ Substance abuse (drugs, alcohol, etc.) Access to healthcare specialist ■ Access to healthcare services Mental health ■ Issues related to aging
