



Resolution #4 - The Big Scoop (aka Auggy's) Stipulation Agreement

Dr. Ludewig made a motion, seconded by Ms. Howard, motion carried in favor of The Big Scoop (Auggy's) Stipulation Agreement. The Big Scoop (Auggy's) is located at 1133 Cook Street, in the Village of Dannemora, had numerous violations cited during a routine inspection, which is a violation of Article 11 of the Clinton County Sanitary Code and Subpart 14-1 of the New York State Sanitary Code.

On May 25, 2021, the Clinton County Health Department (CCHD) conducted an Enforcement Office Conference with the operator of the facility (Mr. Damien Tackett) to review a recent facility inspection violation, violation fine, and a Draft Stipulation (STIP) Agreement.

On June 21, 2021, the results of the Office Conference, Draft Stipulation Agreement, violations and fines were discussed, with the Board of Health then directing that a fine amount of \$500.00 be paid, with the following Conditions being required:

- 1. By <u>July 1, 2021</u>, develop a written plan (submit to the CCHD) for Routine Cleaning Procedures and Schedule to maintain a clean and sanitary kitchen environment. All staff must receive training on this plan. Cleaning logs shall be submitted to the Clinton County Health Department on the 1st of each month for a minimum of three (3) months. The logs shall be kept onsite during all times and be available for inspection.
- 2. At least one facility staff member in a position of control and authority must complete an approved food manager training course such as the "ServSafe Manager" online course or equivalent course approved by CCHD. Certification of course completion must be provided to CCHD by August 1, 2021.
- 3. At least one (1) employee at the facility must complete an approved food handling training course such as the "ServSafe Food Handler" online course or equivalent course approved by CCHD. Certification of course completion must be provided to CCHD by August 1, 2021.
- 4. By <u>August 1, 2021</u>, install a hand wash sink in the ice cream prep area and replace the damaged chest freezer in the storage area.
- 5. That the Clinton County Health Department will conduct quarterly inspections for the next twelve (12) months.

The Board of Health directed that the Stipulation Agreement and final fine determination be sent to the facility owner/operator for their decision to accept said document and fine determination or decline said document and fine determination, thus requesting Administrative Hearing. The Assessed Fine is \$6,500.00 and the Fine Agreement is \$500.00 (with above listed Conditions applicable).

Resolution #5 - COVID -19 ELC School Funding Grant Application and Acceptance

Dr. Ludewig made a motion, seconded by Mr. Garrow, motion carried in favor of the COVID-19 ELC School Funding Grant Application and Acceptance. Funding from this Grant will be used by the Clinton County Health Department with Champlain Valley Educational Services (CVES) to plan and implement COVID-19 screening testing programs to support and maintain in-person learning at public, private and BOCES (CVES) schools in Clinton County. The Grant Revenue is \$2,241,909 and the period is 06/07/21 - 07/31/22.





Resolution #6 - Koto Japanese Steak House Stipulation Agreement

Dr. Ludewig made a motion, seconded by Dr. King, motion carried in favor of the Koto Japanese Steak House Stipulation Agreement. Koto Japanese Steak House, located at 319 Cornelia Street, in the City of Plattsburgh, had a Category 1 Public Health Hazard during a routine inspection, which is a violation of Article 11 of the Clinton County Sanitary Code and Subpart 14-1 of the New York State Sanitary Code.

On June 10, 2021, the Clinton County Health Department (CCHD) conducted an Enforcement Office Conference with the operator of the facility (Ms. Sunny Zheng) to review a recent facility inspection violation, violation fine, and a Draft Stipulation (STIP) Agreement.

On June 21, 2021, the results of the Office Conference, Draft Stipulation Agreement, violations and fines were discussed, with the Board of Health then directing that a fine amount of \$1,500.00 be paid, with the following Condition being required:

1. To review and continue to implement the <u>written plan</u> and policy for the prevention of bare hand contact with ready-to-eat foods submitted to the Clinton County Health Department in 2018.

The Board of Health directed that the Stipulation Agreement and final fine determination be sent to the facility owner/operator for their decision to accept said document and fine determination or decline said document and fine determination, thus requesting Administrative Hearing. The Assessed Fine is \$1,500.00 and the Fine Agreement is \$1,500.00 (with above listed Conditions applicable).

Resolution #1 - Vista Village Mobile Home Park Stipulation Agreement

Dr. Spees made a motion, seconded by Mr. Bowen, motion carried in favor of the Vista Village Mobile Home Park Stipulation Agreement. A public water system monitoring violation was issued for Vista Village Mobile Home Park, located at Charles Way, in the Town of Schuyler Falls, exceeded the maximum contaminated level for Perfluorooctanoic acid (PFOA), which is a violation of Article 8 of the Clinton County Sanitary Code and Subpart 5-1 of the New York State Sanitary Code.

On April 30, 2021, the CCHD had a phone conference with the operator of the facility (Mr. Vance Trudo) to review the violation and terms of the Draft Stipulation (STIP) Agreement.

On May 17, 2021, the results of the Office Conference, Draft Stipulation Agreement, violations and fines were discussed, with the Board of Health then directing that no fine be assessed, with the following Conditions being required:

- 1. By July 1, 2022, submit an Engineer's Report and Engineering Plans for the installation of a Granular Activated Carbon (GAC) Filter at the Vista Village Mobile Home Park to address emerging contaminants in the drinking water.
- 2. By July 1, 2023, complete construction of the GAC Filter.
- 3. By July 1, 2024, drill a secondary (redundant) well source on the property to meet the intent of New York State Part 5 and 10 State Standards.

The Board of Health directed that the Stipulation Agreement and final fine determination be sent to the facility owner/operator for their decision to accept said document and fine determination OR decline said document and fine determination, thus requesting Administrative Hearing.

Resolution #2 - Public Health Emergency Preparedness and Response Grant Application and Acceptance

Dr. Ludewig made a motion, seconded by Mr. Henry, motion carried in favor of the Public Health Emergency Preparedness Grant Application and Acceptance. The Health Department received notification from Health Research, Inc. that funding was available for the Emergency Preparedness Grant. Funding from this Grant will be used for emergency preparedness activities. The Grant Revenue is \$1,077,525 (\$1,000,000 is restricted) and the period is 07/01/21 - 06/30/22.

Resolution #3 – Clinton County Participation in the State Septic System Replacement Funds for Isle LaMotte Watershed Grant Application and Acceptance

Mr. Bowen made a motion, seconded by Ms. Howard, motion carried in favor of the Clinton County Participation in the State Septic System Replacement Funds for Isle LaMotte Watershed Grant. The Health Department received notification from NYS Department of Environmental Conservation and Environmental Facilities Corporation that funding was available for the State Septic System Replacement Fund for the Isle LaMotte Watershed Grant. This Grant provides funding for the replacement of cesspools and septic systems that are having significant and quantifiable environmental and/or public health impacts to groundwater used for drinking water or a threatened or impaired waterbody. The Grant Revenue is \$325,000 (\$75,000 Round 1 Upper Chateauguay Lake; \$250,000 Round 2 Isle La Motte) and the period is 03/01/18 - 12/31/26.

- 1. To operate the food service in accordance with New York State Sanitary Code Subpart 14-1.
- 2. To develop a <u>written plan</u> and policy for the prevention of bare hand contact with ready-to-eat foods. The plan shall include methods for employee training and management enforcement of the policy. The plans shall be kept onsite during all times and be available for inspection.
- 3. To order a new chest freezer and refrigerated prep table for the cook line by December 1, 2021 for immediately installation upon product arrival.

The Board of Health directed that the Stipulation Agreement and final fine determination be sent to the facility owner/operator for their decision to accept said document and fine determination or decline said document and fine determination, thus requesting Administrative Hearing. The Assessed Fine is \$2,000.00 and the Fine Agreement is \$500.00 (with above listed Conditions applicable).

PRESENTATIONS:

Corporate Compliance Annual Training by Jennifer Trudeau, Quality Coordinator

Ms. Trudeau reviewed the Director of Public Health and Governing Board expectations, best practices for Governing Boards and the Director of Public Health responsibilities with members present. She also reviewed the CCHD Corporate Compliance Program structure, best practices and potential risk areas.

PHAB update by Jennifer Trudeau, Quality Coordinator

Ms. Trudeau stated that currently, 14 (of the 57) local health departments (LHDs) in New York State are accredited; across the United States 276 LHDs are accredited. The focus of reaccreditation is different than initial accreditation. PHAB looks to ensure that we continue to meet initial accreditation requirements, but they're also looking to see continued improvement (especially in areas previously identified as needing improvement). The site visit provided an opportunity for PHAB representatives to ask us questions to elicit more information where needed, and to highlight areas where we have done well. From our site visit, one measure was reopened (because PHAB didn't feel our example met the requirement), and we were provided an opportunity to re-submit an example. On 6/16/21 we received our site visit report—we met ALL measures (i.e., successfully demonstrated all requirements). YAY! The report also provides some feedback on opportunities for improvement and areas of excellence. You can contact the Quality Coordinator for a copy of the report. The PHAB Accreditation Committee meeting was held on 8/24/21 and CCHD received notification that we were reaccredited. Now work starts on Reaccreditation. The Standards and Measures Version 2022 will have a public vetting process before its final release. Then CCHD preparation for the next reaccreditation cycle begins.

DISCUSSION ITEMS:

Zack's Shack - Clinton County Fairgrounds Permit to Operate

Mr. Davies provided members present with a copy of the correspondence sent to the facility owner explaining the Notice of Intended Enforcement process and lack of response. Mr. Davies stated that several attempts were made to contact this facility owner to rectify/resolve violations with no response to date. Mr. Davies suggested that instead of pursuing this issue any further via formal Administrative Hearing that the facility will not be allowed to operate in Clinton County in the future. Dr. King made a motion seconded by Mr. Miller. Mr. Davies will alert all parties.

EHS Update

Mr. Davies stated that Auggy's (The Big Scoop) has paid the fines and the facility is for sale. He will also be revising the Fine Schedule, it will be ready for review by the November Board of Health meeting.

Director of Public Health retirement and next steps

Mr. Kanoza stated that he will be retiring on December 31, 2021. The Backfill process is being completed and the recruiting process has begun. Mr. Kanoza will return in 2022 to provide orientation to the new hired Director.
